4. POLICY & PROCEDURE:

4.1 Compulsory Health Check-up:

4.1.1 Employees in regular rolls who are above 40 years of age (irrespective of their Grade) are eligible to undergo Compulsory Health Check-up once in Two Years.

4.1.2 The details of investigations that are carried out is indicated below:

(a) Haematology:

Hb, PCV, RBC, MCHC, MCV, MCH, Total WBC, Diff. Count, ESR, PLT, Peripheral Smear, Complete Urine Exam & Stool Routine Test.

(b) Histopathology:

(c) Biochemistry:

FBS & PLBS Creatinine, Urea and Uric acid, Lipid Profile (Total Cholesterol, HDL Cholesterol, LDL Cholesterol, VLDL Cholesterol, Triglycerides, Cardiac Risk ration) Liver function Test (Total Bilirubin, Direct Bilirubin, Indirect Bilirubin, Alakaline Phosphate, SGOT, SGPT, Total Protein, Albumin, Globulin ratio), Serum Calcium

(d) Serology:
